That is why we are calling on our Deputy-Governors and all Club Presidents to make sure these forms are submitted as soon as possible. You also need to submit to National Headquarters copies or proof of submission as well.

The insurance form can be downloaded from our National website; any questions please contact Melanie Nieson, National Risk Management Coordinator for assistance. For the insurance forms unless you have changes such as, new projects, then it is just a

matter of quickly answering the questions, signing the form and sending it in to our insurer.

Incorporation Papers can be submitted online through a company called, oncorp.com. We can't recommend this strongly enough unless you have access to legal help within your club. For \$55.00, that's right \$55.00, they will assist and file your incorporation papers with the Ontario Government online. It's just that simple. Check it out and see if that is something your club may find useful. Without up to date Incorporation Forms, you club will be put into Not in Good Standing by National and if something should happen, the club and our Association could very well be in a whole lot of legal trouble.

For the T-2 Income Tax short form, unless you're a club that owns significant assets, then that is the form to complete. If you require assistance, please contact our District Treasurer Paul Dahmer and he will help you. His contact information is printed in the President's Planner or you can contact either Elaine or myself and we will pass along your requests to Paul.

District Risk Manager and Past Governor Darrell will be following up with you in regards to Insurance and Incorporation papers but we are asking that you complete these as soon as possible. For the clubs that have already done so, we say thank-you very much, it's much appreciated.

One again, read through the mailing and pass the information along so that all of us are singing from the same song sheet. Happy Holidays and Merry Christmas to you all and we hope to come see you very soon.


