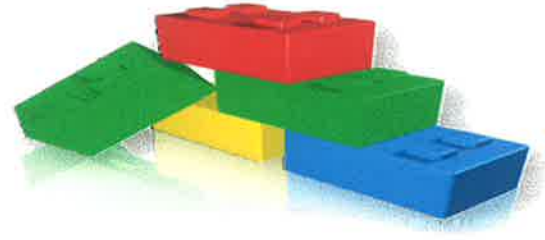

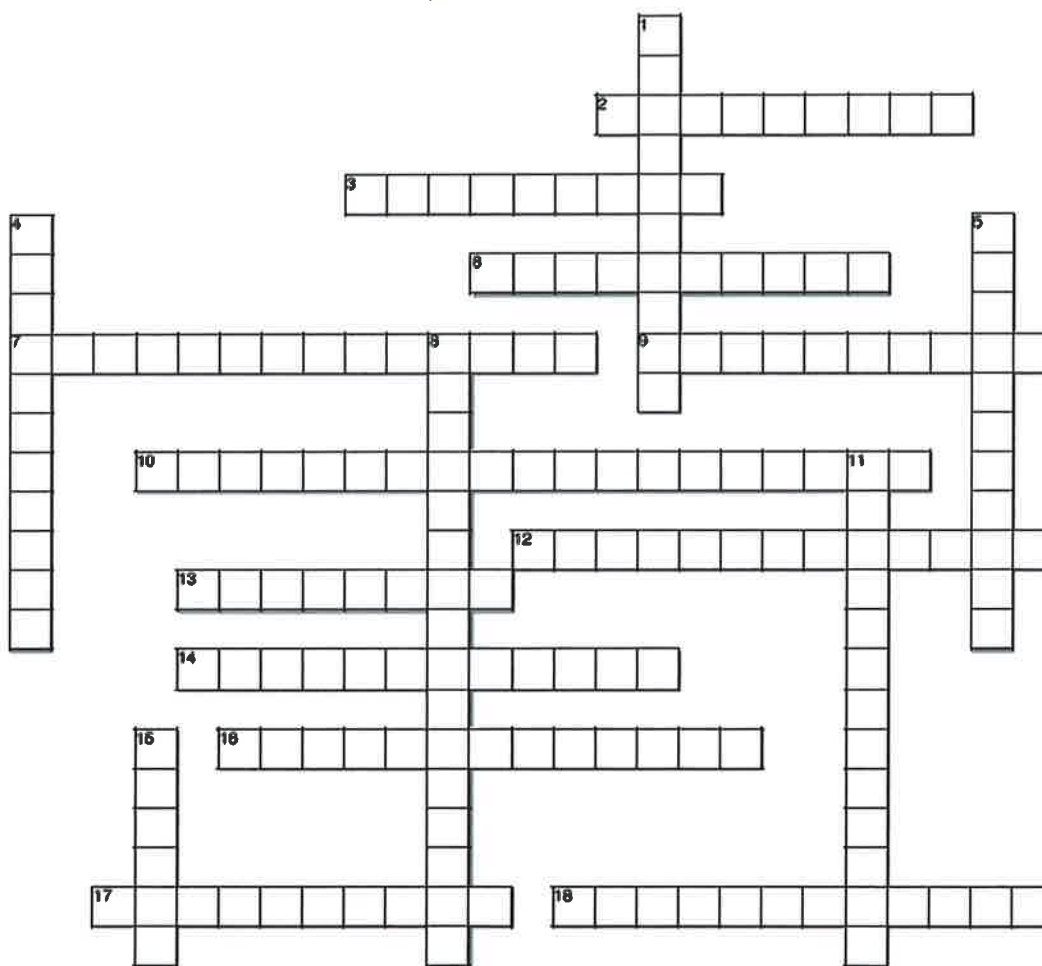

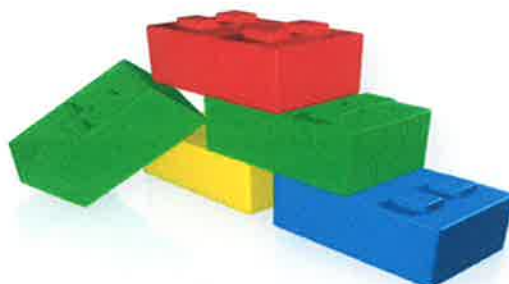

***What does "Kinnect. Invest. Build." mean to Clubs?***

- **KINNECT** – We do not expect members to come to us to learn about our goals and get information. The KIB will come to you. We will not be reciting the District's goals or expecting you to adopt them, because the only goals we care about are the goals each Club sets for themselves. *The KIB's only goal is to help you achieve yours.* The first step in "Kinnect" is to find out what your Club's goals are and how we can help you achieve them. Then we bring the education to you; we'll come to your area and offer education based on your needs, not ours.
- **INVEST** – once we can Kinnect with Clubs like yours, the real work begins! We are dedicating our time, energy and resources to helping your Club achieve its goals. If you need more members, we'll help you with recruitment and retention strategies. If you need help with dues, we are already armed with ideas to help bring in revenue to offset dues. If you need new and fresh ideas for service projects – or a few extra hands – we're there for you. Our help is based entirely on your needs and goals. Many Clubs/members consider District to be merely an expense, because dues have become an obstacle. The KIB Team is looking to change that. We want Clubs to consider their District Council and District dues to be an *Investment*, not an expense... the KIB Team is designed to be a good investment with a great return.
- **BUILD** – the strongest buildings are started with strong foundations. A strong District 1 will only realize strength when it has strong Clubs. ## **Zone By-Laws**



### **Zone K Kinette's of District One**

1. Each Club shall be assessed \$ 5.00 / member for the operation of the Zone, to be paid to the Zone Kinette Deputy Governor no later than Zone Conference. This assessment shall be based on the previous February 28<sup>th</sup> Census that immediately precedes Zone Conference.
2. The Zone Dues go towards the expenses of the Kinette Deputy Governor, above the District Allotment for telephone, mileage, photocopying, stationary, executive expenses or as she deems necessary.  
Gifts not to exceed the following maximums shall be paid out of Zone Dues – Judges – \$ 10.00, Joke-off Winner - \$ 10.00, Speak-off Winner - \$ 25.00, Bulletin - \$ 25.00
3. The cost of engraving for the Bulletin Award Plaque and the cost of the bar attachments for the Zone Banners and respective club banners, shall be paid out of Zone Dues.
4. Meals for the District Executive and Zone Executive in attendance at Zone Conference shall be paid as part of Zone Conference expenses by the hosting club.
5. The Zone Conference host club will arrange to have Judges present for Speak-off Competition.
6. That the history of each Kinette club is important and unique and this history becomes a vital part of each Kinette club, that the following award: the Zone K Scrapbook Award will be presented at the Annual Zone Conference. The award shall consist of the Zone Banner, which has been donated by the Kinette club of Clinton, with the bar attachment for the winning club's home banner.
7. The Zone K Speak-off Award consists of a Zone Banner, with a bar attachment for the winning club's home banner.
8. The Zone K Bulletin Award consists of a Zone plaque, Zone Banner with a bar attachment and a bar attachment for the winning clubs home banner.
9. The Deputy Governor Banner shall be presented annually to the Deputy-Governor Elect. It will be accompanied by a bar attachment and a bar attachment for the home club's banner
10. These By-laws shall be reviewed every year at Zone Conference in order to change as our Zone will change
11. These By-laws shall not be changed without a 2/3 majority of the voting delegates at Zone Conference
12. Zone Conference shall be a non-smoking meeting
13. Every Kinette club in good standing in Zone K shall be deemed with the following voting delegates; 1 vote per member on their Roster per the February census.
14. Scrutineers shall be picked for the voting by the present Deputy Governor.
15. Order of Zone K Zone Conference host Clubs: 1) Clinton 2) Mitchell 3) Hensall 4) Goderich 5) St. Marys

## CHAPTER 3: MEETING OF MEMBERS (CONVENTIONS)

### 3.01 Business of Annual Meeting of Members

In accordance with GOB section IV, the annual general Meeting of Members of the Association shall be held to transact such business as is required by the Act and as determined by the Board of Directors from time to time, which shall include, but not be limited to, the following:

- (a) to receive a report or reports from the Board of Directors about the prior year's activities;
- (b) to receive a report from the Auditor on the financial statements for the Association in accordance with the Act;
- (c) to elect Directors as required;
- (d) to appoint an Auditor for the current fiscal year and to fix or authorize the Board of Directors to fix remuneration for the Auditor;
- (e) to approve past actions of the Directors; and
- (f) to transact any other business properly brought before the meeting.

### 3.02 Persons Entitled to Be Present

In addition to Accredited Delegates of Clubs, Directors, Officers, staff and others permitted by the Act, as set out in GOB section 4.06, the following persons shall be entitled to attend a Meeting of Members and participate, but shall not be entitled to vote:

- (a) any Active Member In Good Standing of a Club In Good Standing, as per GOB section 2.06(c); and
- (b) such other persons as the Board or the Meeting chair may allow.

These additional categories of Persons have traditionally been referred to within the Association as convention delegates.

### 3.03 Club Voting Rights

Further to GOB sections 2.06 and 4.09, the following policies and procedures shall apply in relation to voting rights and processes for conventions at all levels of the Association:

- (a) As Members of the Association, Clubs are entitled to vote at all National, District and Zone conventions/conferences only through individual registered Accredited Delegates (or Alternate Accredited Delegates as applicable), duly appointed by the Club, to vote on the Club's behalf.
- (b) For normal "show of hands" votes, each Club is entitled to ONE vote only, regardless of the number of members of that Club who are present, to be exercised only by the Club's registered Accredited Delegate (or Accredited Alternate Delegate as applicable).
- (c) For the purposes of poll and ballot votes only, the number of votes to which a Club is entitled is equal to the club's Official Membership. Official membership means the total number of a Club's Active Members registered on the National membership roster as of:
  - (i) in the case of a National Convention/Meeting of Members, June 30th immediately prior to the start of the Convention; and



- (ii) in the case of a District convention, Zone conference or other Special Meeting of Members, the month end date that is more than thirty-five (35) days prior to the start of the convention, conference or Meeting.

### **3.04 Appointment, Certification and Registration of Accredited Delegates**

Overall rules concerning the Club appointment of Accredited Delegates and Alternate Accredited Delegates, and the manner in which they vote on the Club's behalf, are set out in GOB section 2.06. Section 2.06(e) provides for additional related policies and procedures, which as follows.

#### **(a) Appointment**

- (i) In addition to appointing one (1) Accredited Delegate, a Club may designate in writing up to three (3) Alternate Active Members in Good Standing. Alternative Accredited Delegates can be an Active Member in Good Standing of the club or an Active Member of another club.
- (ii) A Club is not obligated to appoint all four, or any, Delegates to act on its behalf if it does not wish to exercise its right to vote.
- (iii) To qualify for designation as an Accredited Delegate or Alternate Accredited Delegate of a Club, a Person must:
  - (1) be duly appointed at a regularly constituted meeting or executive meeting of the Club, to vote on the Club's behalf; and
  - (2) be an Active Member In Good Standing of a Club In Good Standing.

Although not a mandatory qualification requirement, Persons should only be so designated if they plan to attend the Meeting of Members or convention for which the appointment is being made.

#### **(b) Role and Ranking of Alternate Accredited Delegates**

- (i) Alternate Accredited Delegates are intended to act in place of the Accredited Delegate in the event that the Accredited Delegate is unable to be present at the Meeting of Members.
- (ii) A Club must assign a ranking to the order of priority in which Alternates will act on behalf of the Club at Meetings of Members; i.e. Alternate number 3 will only act in the event that none of the Accredited Delegate nor Alternates 1 and 2 are present. Such ranking must be indicated in the Club's Certification provided to National headquarters.

#### **(c) Certification Process**

For any Person to be recognized by the Association as the Accredited or Alternate Accredited Delegate of a Club, the Club must have provided duly executed evidence of its designation of that Person. Accordingly,

**In the case of National Meetings of Members:**

- (i) The Club shall complete all portions of the Association's Accredited Delegate Certification Form, as prescribed from time to time by National headquarters and approved by the Board.
- (ii) The Form shall be duly executed by any two of the Club President, Secretary or Vice President.
- (iii) The Club shall submit said completed Form to National headquarters not later than July 15 of the year in which the Meeting of Members is being held.
- (iv) Such submission is subject to validation by National headquarters as to the Club's current In Good Standing status and proper execution of the Form.
- (v) If the Form is deficient, staff shall notify the Club president on the following business day. The Club shall have two (2) business days to remedy the Form deficiency.
- (vi) The Club must be In Good Standing as of the date of submission deadline according to National headquarters' official records; otherwise the Club shall forfeit its votes at the Meeting of Members to which the Form applies.

## District One Kinette Public Relations Award

*Deadline: 30 days prior to District Convention for the year April 1-March 31*

### Rules:

1. Each club wishing to compete for the award must submit to the District Awards Chair 30 days prior to District Convention, a presentation copy containing evidence of all news media coverage obtained by the club, together with a written summary of the overall publicity obtained by the club during the period of April 1st to March 31st, immediately prior to the current District Convention.
2. The presentation copy shall include:
  - a) With respect to newspaper, magazine or coverage by other printed matter; newspaper clippings, pictures or articles taken directly from the publication.
  - b) With respect to television or radio coverage, a summary written by a club member outlining all pertinent factual data. No video or audio tapes to be included.
  - c) Any other manner in which the club or its projects are recognized or made known to the community shall be reported in full.
  - d) A written evaluation by the club president or public relations chair outlining the effect of the publicity on club projects or the reputation of the club in the community as well as:
    - i) The membership of the club
    - ii) The population of the community
    - iii) The availability of various news media
3. *Where Zone competitions are held, the Zone winners only will qualify for District judging.*
4. Judging shall be done by the heading and point system as outlined (100 points):

a)	Judges evaluation of PR effectiveness	<b>30 points</b>
b)	PR Scrapbook contents; Print media pictures and articles; Written summaries of radio and TV coverage and other promotional material (as local facilities allow)	<b>50 points</b>
c)	Existence of written planned PR program or emphasis in club	<b>10 points</b>
d)	President's or Public Relations Chair written evaluation of PR effectiveness	<b>10 points</b>
<b>GRAND TOTAL:</b>		<b>100 POINTS</b>

### 5. Criteria for Judging:

The Awards Chair, in reaching a decision, shall consider the following items:

- the membership of the club
- the existence of a written planned public relations program or emphasis in the club
- the population of the community
- the availability of various media
- the amount and source of publicity
- the effectiveness of the publicity, and
- such other matters as the committee deems relevant

### Reward:

Recognition – a framed certificate will be awarded to the winning club.

# Ferne Carter Memorial Speak Off Award

*Presented at District Convention*

## Objective

- To encourage members to develop and improve their public speaking skills.
- To promote self-development in Kin by means of public speaking.

## Eligibility:

1. All active, active life or associate members in good standing shall be eligible to compete for this award with the following exceptions:
  - a. The competitors of a national public speaking competition will be considered ineligible to compete at club, zone, district or national level for a period of 2 years following the national convention in which they competed.
  - b. The winners of a national public speaking competition will no longer be considered eligible to compete at club, zone, district or national level having achieved the highest reward for self-development in Kin through the public speaking competition.
  - c. The winner of the prior year District competition will also be ineligible to compete at club, zone and District levels for a period of two years.
2. The present members of the District Executive and the present and incoming members of the National Board of Directors are not eligible to compete in the current competition.
3. The Zone Winner's name and club will be submitted to the District Governor(s) or District Awards Chair, at least 10 days prior to District Convention, to be eligible to compete in the District Competition.

## Management:

1. The public speakers marking guideline shall be used as a guide for speakers and judges alike (ATTACHED)
2. Speeches shorter than five minutes or longer than seven minutes thirty seconds will be disqualified (see item #3)
3. Lights or flash cards will be used to advise the speaker at the 5 minute, 6 minute and 7 minute point of their speech (there is a thirty second grace to conclude speech)
4. The speech will be materially the same as presented at Club and Zone Competitions
5. The speech will not include a power point component
6. The speech shall be authored by the speaker
7. Electronic devices such as projectors cannot be used

## Judges:

- The District Awards Chair will appoint a panel of 3 judges
- At least one judge will not be an active or active life member of the Association.
- The judges will select a chair who will be responsible to co-ordinate the judging
- The judges will provide the name of the winner and a written critique for each speaker to the District Awards Chair.

## Reward:

The winner will receive a personal plaque.
